As per the Information Technology Act, the electronic documents have legal recognition of electronic records. E-mail is used as a major mode of communication in government organization. The guidelines with respect to use of email services to ensure secure access and sensitive data exchange are provided in E-mail policy of Govt. of India. Most of the communications are done through electronic mail in MESCOM also. As per the Cyber Security guidelines vide reference (1)&(2), the information shared by MESCOM through electronic media is one of the critical information infrastructure.

MESCOM has already procured 'mesco.in' domain for its official/general correspondence for all R-APDRP areas including Corporate Office, Office, Zonal Offices, Circle Offices, Division Offices, Sub-Division Offices and Section Office. Details of existing email ID's are enclosed in Annexure-II. This domain ID's are protected against security vulnerabilities and provides secured communication.

It is observed that, even though the official email ID's are available for R-APDRP areas, the email correspondences are carried out through other free domain email IDs (gmail, rediffmail, yahoo mail etc...) which may lead to security threat issues. Further, regular updates related to R-APDRP application is also communicated to 'mesco.in' domain emails only which helps the end users to keep informed on R-APDRP activities and complete their module related works.

In this regard, I am directed to inform you on the compulsory usage of mesco.in domain emails for further official correspondences. The officers who do not have official email ID's are requested to share the details as per Annexure – I through email (itwing@mesco.in).
