GENERAL INSTRUCTIONS

1. The demand for shortfall in Security Deposit has to be raised by the AEE to the consumer after reviewing the adequacy of the amount of Security Deposit in the first quarter of every year based on the average consumption for the preceding year.
2. The detail of calculations of Additional Security Deposit is provided in the Annexure enclosed.
3. If the consumer fails to pay the Additional Security Deposit demanded by the Licensee, the Licensee shall disconnect the power supply to the installation without further notice.
4. For any clarifications please contact concerned Sub Division office
5. **Indicative Maximum time limit:**
 - ✓ In case the Consumer has no objections on the amount demanded, the Additional Security Deposit shall be paid within 30 days of the date of demand.
 - ✓ In case the Consumer has any objections for the said demand, he may file his objections within 7 days from the date of receipt of such demand notice
 - ✓ The Licensee (MESCOM) shall furnish all the necessary details to justify the claim of ASD within 7 days of the receipt of objections.
 - ✓ In case of revised demand, the payment shall be made within 15 days of the date of revised demand.
